2. Approval minutes – Teams meeting 16.03.21

2.1. Strategic Roadmap

StrMnt updated on the evolution of the Strategic Roadmap, which had been designed in order to come to a Strategic Plan. This plan will define the COHEHRE identity: vision, mission and core values. It was agreed to add an introduction of the Strategic Roadmap to the online GA.

2.2. Marketing plan

4. COHEHRE Academy

The Academy is going through a restructure. There will be a more horizontal distribution of tasks. The Academy consists of 3 parts: Students, Staff, Development & Innovation. Each of the parts have been allocated a coordinator and collaborators. The profile of each role has been defined. They will try this new structure as a pilot until the Rotterdam conference to evaluate and finalise this new structure.

The Academy will meet in Portugal in October 2021.

5. COHEHRE Research


The team has been working on getting the platform ready to launch by the end of June. It was decided to postpone the launch to September. The platform access will also be added to the COHEHRE website.

6. COHEHRE Strategic Management

A lot of effort went into creating a new contact list of deans and directors as to be on a direct line with them. The StrMnt team meet every 2 weeks to discuss two main topics: to give internal advice to COHEHRE/council in relation to StrMnt topics and secondly to organise activities for Strategic Managers.

A first webinar was organised in May on the topic of 'The European alliances initiative and its governance stuctures.'

Vision

Qualities

COHEHRE distinguishes itself by offering **informal** activities for professionals and students where they can **meet**, **present and inform** themselves of the **newest developments** in health and rehabilitation. COHEHRE offers it members a stage to expand their international network in a **collegial and friendly atmosphere**.

It is believed to be stronger to have one shared vision with all the branches but that all branches will need to define their own core values. The roadmap will need to be used from Q3 onwards by each of the branches in order to come to a result. It is of an importance that the Core Group of each of the branches is involved in the agreement/revision of the vision, mission, core values and qualities that have been drafted and to be involved in drafting the targets from Q3 onwards on the Roadmap.

The Strategic Plan will be fully introduced at the GA in Rotterdam as well as how COHEHRE will be organised in the future. Each of the branches could elaborate on how they see the strategic goals implemented in their branches. The outcome could also be featured in the Annual Report 2021.
