1. Rotterdam Conference

a. Meeting conference team

A meeting will be organized with the Rotterdam organizing team.

b. Date

A date proposal will be sent to Rotterdam

2. COHEHRE Academy

Instead of organizing pre-webinars, the Academy will organize a webinar in May presenting an overview of the activities for the whole year. The format will consist of short films (3-4 min.) presenting the activity (incl. testimonials, snip bits of the course of the previous year, etc.) followed by a Q&A session.

The team will also investigate the possibility of sending out the surveys on Teams, so that all info could be gathered in one place, easily accessible to the council and pillars.

3. COHEHRE Research

The Research team has set out a plan to organize the following activities:

- Two webinars containing accepted sessions from the postponed Rotterdam conference.
 - \Rightarrow 1 afternoon webinar in May and one in June
- A webinar/seminar on Erasmus+ once the call is out. This will be a collab with the Academy.
 - ⇒ End of June / Beginning of September.
- Followed by a specific meeting on Erasmus+ with an international speaker.
 - \Rightarrow December

A meeting has been set up with ICT to address issues regarding the SPOCS website.

The SPOCS will be once more approached to enroll on the website and will be shown what they would get out of it if they would enroll.

4. COHEHRE StrMnt

The StrMnt Core Group is now complete with the addition of 3 new team members.


Two topics will be featured on its agenda:

The StrMnt team has met up and set up the following plan:

A strategic roadmap has been developed in order to come to a strategic plan. This plan will define a clear vision, mission and core values which will be taken to each of the pillars in which actions will be defined to comply with the vision, mission and core values.

⇒ Vision, mission and core values should be set before summer

5. Marketing plan 2021

5.1. Mission and vision
